ACTION ITEMS

A. Pacific Seafood Lease

President Cline states - the Port Commission recognizes per RCW 53.08.085
that a security deposit is required from tenants when signing a lease
agreement. The port requires rent to be secured; however, at a lower
security amount than required by state law. The port will be obtaining a
deposit of zero (\$0.00) dollars from Pacific Seafood. Therefore, I move that
we approve the lease with Pacific Seafood. Commissioner Peterson seconded
the motion.

Vote was unanimous. The motion was carried.

B. Preliminary Environmental Proposal Award for Guild Road Industrial Park

<u>Discussion: The Commission and Executive Director Keene, thoroughly discuss each proposal that was received.</u>

<u>President Cline made a motion to enter into agreement for Phase I of the Guild Road Industrial Park project with ELS, Ecological Land Services, in the amount of \$34,664.00. Commissioner Peterson seconded the motion.</u>

Vote was unanimous. The motion was carried.

C. Schwabe, Williamson and Wyatt Legal Expenses

<u>President Cline made a motion to approve \$36,338.60 in legal expense to Schwabe, Williamson & Wyatt. Commissioner Peterson seconded the motion.</u>


